## Terms and Conditions for Journey into Celtic Seership

### 1. Application of Terms and Conditions

1.1. These terms and conditions (“Terms”) apply to the Journey into Celtic Seership course (the “Program”) operated by The Centre for Shamanism Ltd (“we” or “us”). By applying to join the Program, you agree to these Terms, which prevail over any inconsistent terms or conditions implied by law, trade custom, practice, or course of dealing, except where statutory consumer rights apply.

1.2. These Terms should be read alongside our Website Terms of Use, Privacy Policy, and Acceptable Use Policy (all available at [www.centreforshamanism.com](http://www.centreforshamanism.com)).

1.3. Any content you post or submit to our site or Program community space—including text, images, audio, video, and links—is subject to the Acceptable Use Policy and the “I Language” Communication Guidelines at all times.

1.4. If you are a corporate entity, “you” includes your officers and employees, and you must ensure they comply with these Terms.

1.5. This Contract is between you (the individual or entity registering) and us. It takes effect upon our confirmation email accepting your registration and continues until terminated according to these Terms.

1.6. Online order process:

1.6.1. Add the Program to your cart, proceed to checkout, and make payment as directed.

1.6.2. If using PayPal, you will be redirected to complete payment and then back to our site.

1.6.3. We will email you to acknowledge your order and confirm acceptance of your application.

1.6.4. If there are errors in your order, email [theteam@centreforshamanism.com](mailto:theteam@centreforshamanism.com) as soon as possible to correct them.

1.7. We may update these Terms occasionally; the latest version will always apply.

### 2. Membership

2.1. The Program runs for 8 weeks, from Friday 24 October 2025 to Sunday 21 December 2025. This includes live and recorded classes, ceremonial healing circles, paired practice sessions, case study submission and marking, PDF guides, and community space.

2.2. We may, at our sole discretion, refuse membership or revoke access without providing reasons.

2.3. The Program continues until the stated end date unless terminated in accordance with clause 6.

2.4. You must keep login details confidential and notify us of any unauthorized use. You indemnify us against claims or losses arising from unauthorized use beyond reasonable mistakes or normal participant activity.

2.5. Program materials are hosted on secure third-party servers. While we aim to maintain availability, we are not liable for any periods of unavailability or corrupted content, though we will

make reasonable attempts to restore access or provide corrected materials.

2.6. Program materials are available for the duration of the course and for 30 days after the Dedication Ritual (Closing Ceremony), please make sure to download anything you would like to keep as your access to the space will be removed after this 30 day period.

2.7. Program materials are for guidance and training only; they do not constitute individualised advice.

2.8. This Program uses a unique communication model designed to keep our shared space safe, respectful, and grounded in personal truth. All participants are required to follow the “I Language” guidelines throughout the Program’s community spaces, live calls, and partner practices. This means:

- Speak only from your own experience, in the first person, using “I” statements (e.g., “I experienced...” or “In my journey, I noticed...”).
- Avoid giving advice, instruction, unsolicited interpretations, or using “you should” / “you need to” language.
- Refrain from making generalised statements or presenting personal beliefs as facts. Instead of saying “We are all one,” you might say “I feel that I am one with all.”
- When responding to others, share your own perspective without judgment or correction (e.g., “I feel challenged by this idea” rather than “That’s wrong”).
- Avoid any form of business promotion, sharing of external links, or directing participants to your website, social media, or services.

These guidelines are intended to prevent ego-driven dynamics, promote deep listening, and encourage integration at each participant’s own pace. If a participant repeatedly breaches these guidelines (for example, after two or more reminders) and does not respond to corrections, we reserve the right to remove them from the Program without refund. The full version of the “I Language” Communication Guidelines is provided within the Program materials and forms part of these Terms.

### **3. Payment**

3.1. Total Program fee: \$497 USD. Early-bird pricing: \$397 USD until 30 September 2025.

3.2. Payment may be made in full or in installments, as detailed on the sales page.

3.3. Instalments occur on the registration date and subsequent months as applicable.

3.4. Monthly plans expire once full payment is received.

3.5. Except as required by law (including the 14-day cooling-off period for UK and EU consumers), payments are non-refundable. If unforeseen circumstances prevent attendance,

you may request one deferral to the next scheduled Program. Deferrals:

- Must be requested by email to [theteam@centreforshamanism.com](mailto:theteam@centreforshamanism.com).
- Should ideally be made before the Program start date; requests within the first two weeks are considered only in exceptional circumstances.
- Are limited to one per participant and are not guaranteed.

## **4. Our Obligations**

- 4.1. We warrant the Program will be of satisfactory quality and reasonably fit for purpose.
- 4.2. Except as above, all warranties are excluded to the fullest extent permitted by law. The Program's success depends on factors beyond our control; specific outcomes, spiritual or personal, are not guaranteed.
- 4.3. We aim for accurate information, but are not liable for claims arising from outdated or inaccurate content.
- 4.4. Personal data will be processed according to our Privacy Policy:

## **5. Intellectual Property**

- 5.1. We retain all intellectual property rights in Program materials; these cannot be transferred.
- 5.2. Materials may not be copied, shared, published, or distributed outside the Program.
- 5.3. Participants have a limited, revocable licence to use Program materials solely for the Program.
- 5.4. Unauthorized audio or video recordings are prohibited.
- 5.5. Portions of the Program may be recorded; by participating, you consent to use of your image and voice, including for promotional purposes, without further consent or payment.
- 5.6. Some Program content may be publicly available.
- 5.7. These intellectual property provisions survive termination.

## **6. Term and Termination**

- 6.1. This Contract continues until the Program concludes, except for terms stated to survive termination.
- 6.2. No refunds will be provided except where required by law.
- 6.3. Deferrals: see 3.5.
- 6.4. You may terminate the Contract after the initial term by emailing [theteam@centreforshamanism.com](mailto:theteam@centreforshamanism.com). Access ends immediately upon termination. No refunds will be provided; recurring payments remain your responsibility.
- 6.6. Any unpaid fees remain due upon termination.
- 6.7. Termination does not affect accrued rights or obligations; delay in exercising termination rights does not constitute a waiver.
- 6.8. Provisions intended to remain in force post-termination continue.
